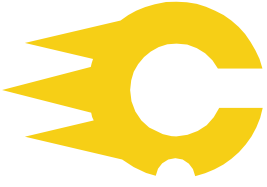


Quality Policy

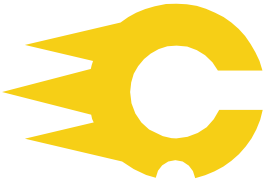


Information Security and Personal Data Management System Policy

- Providing training to develop technical and behavioral competencies that will increase awareness of information security and personal data,

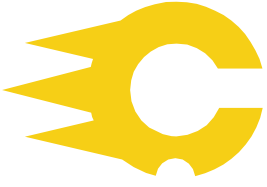
