## Which Cookies Are Used for Which Purposes?

### Generally

As ÇELİKEL, we use cookies for various purposes on our site and process your personal data through these cookies.

These purposes are mainly:

- ✓ **To perform the basic functions necessary for the operation of the site.** For example, the logged-in members do not need to enter passwords again while visiting different pages on the site.
